

LEGAL # 6874**PUBLIC NOTICE**

On or about March 19, 2010, the Greene County Board of Commissioners on behalf of Wright Township intends to apply to the Indiana Office of Community and Rural Affairs for a grant from the Community Focus Fund of the State Community Development Block Grant (CDBG) program. This program is funded by Title I of the federal Housing and Community Development Act of 1974, as amended. These funds are to be used for a community development project that will include the following activities: Renovations of the Wright Township Fire Station Project. The total amount of CDBG funds to be requested is \$500,000. The amount of CDBG funds proposed to be used for activities that will benefit low and moderate income persons is \$262,250. The Applicant also proposes to expend an estimated \$56,000 in non-CDBG funds on the project. These non-CDBG funds will be derived from the following sources: Wright Township Cumulative Fire Funds.

Greene County will hold a public hearing on December 17, 2009 at 7:00 p.m., at the Wright Township Fire Station, RR1, Highway 59, Midland, Indiana 47445 to provide interested parties an opportunity to express their views on the proposed federally funded CDBG project. Persons with disabilities or non-English speaking persons who wish to attend the public hearing and need assistance should contact the Southern Indiana Development Commission, P.O. 2009. Every effort will be made to make reasonable accommodations for these persons.

Information related to this project will be available for review prior to the public hearing as of November 30, 2009 at the Greene County Auditor's Office located at the Greene County Courthouse, 1 E Main Street, Bloomfield, Indiana 47424 between the hours of 8:00 a.m. to 4:00 p.m. or at the Southern Indiana Development Commission Office, 405 JFK Avenue, Suite A, Loogootee, Indiana 47553 between the hours of 8:30 a.m. – 4:30 p.m. Monday thru Friday. Interested citizens are invited to provide comments regarding these issues either at the public hearing or by prior written statement. Written comments should be submitted to Auditor's Office, Greene County Courthouse, 1 E Main Street, Bloomfield, Indiana 47424 no later than December 15, 2009 in order to ensure placement of such comments in the official record of the public hearing proceedings. A plan to minimize displacement and provide assistance to those displaced has been prepared by Greene County and is also available to the public. This project will result in no displacement of any persons or businesses.
