Notice is hereby given the taxpayers of Greene County, Indiana, that the County Council of Greene County, at the Greene County Courthouse in Bloomfield, IN on September 7, 2010 at 9:00 a.m. will conduct a public hearing on the budget. Following this meeting, any ten or more taxpayers may object to a budget, tax rate, or tax levy by filing an objecting petition with the proper officers of the political subdivision within seven days after the hearing. The objecting petition must identify the provisions of the budget, tax rate, or tax levy that taxpayers object to. If a petition is filed, the political subdivision shall adopt with its budget a finding concerning the objections filed and testimony presented. Following the aforementioned meeting, the fiscal body will meet at the Greene County Courthouse on September 27, 2010 at 4:00 p.m. to adopt the following budget:
